Position Description

Along with two Greek Life staff members, one or two peer leaders will comprise the teaching team. The Peer Leader is an integral part of the teaching team. The Peer Leader is expected to help plan, implement, and evaluate the individual classes. The Peer Leader will be the lead facilitator for a minimum of two classes. She/he is also expected to serve in a mentor capacity for the students in the class. The ideal candidate will be an ethical role model with demonstrated leadership experiences. Inappropriate relationships between the Peer Leader(s) and course participants are strictly prohibited and will result in loss of position for the Peer Leader.
